ASX ANNOUNCEMENT Update from Deed Administrators of Antares Energy Limited (Subject to Deed of Company Arrangement) (ASX:AZZ)

ASX waiver – ASX Listing Rule 14.7

Sydney, 19 February 2018 — Quentin James Olde and Michael Joseph Ryan of FTI Consulting ("the Deed Administrators") advise that the ASX has agreed to grant the Company a waiver from ASX Listing Rule 14.7 to the extent necessary to enable the Company to issue securities to related parties more than 1 month after Shareholders approved the issue of securities at the Extraordinary General Meeting held on 23 January 2018.

The terms of the waiver are as follows:

DECISION

- Based solely on the information provided, ASX Limited ("ASX") grants Antares Energy Limited ("Company") a waiver of listing rule 14.7 to the extent necessary to permit the Company to issue the following:
 - 1.1. 92,500,000 fully paid ordinary shares ("Shares") at an issue price of A\$0.0025 ("First Placement Shares");
 - 1.2. 46,250,000 options exercisable at \$0.01 at an issue price of \$0.000025 each exercisable at \$0.01 each on or before 30 June 2020 ("First Placement Options"); and
 - 1.3. 6,000,000 fully paid ordinary shares ("Shares") at an issue price of A\$0.01 each ("Second Placement Shares"),

(together the "Related Party Securities"),

as approved by the Company's shareholders at the annual general meeting held on the 23 January 2018 ("**Meeting**"), later than one month after the date of the Meeting, on the following conditions:

1.4. The Related Party Securities must be issued no later than 23 April 2018 and otherwise on the same terms and conditions as approved by the Company's shareholders at the Meeting.
